A. PROJECT DESCRIPTION

The Daimler Group, Inc. is the Design-Build Construction Manager and we are seeking subcontractor bids for the construction of a new Corporate Office campus for Ohio Health. The Project consists of a 270,000 SF Main Office Building and a 1379 space parking garage with an interconnecting overhead bridge all located on a 13 acre site. The building will consist of a structural steel frame, exterior metal stud framing with continuous rigid insulation sheathing, brick veneer, metal panels, aluminum window wall/storefront/curtain wall/entrances, membrane roofing. Bid Package 1 includes Concrete, Steel, and Earthwork/Site Utility Demolition only, all other trades to be bid in other bid packages

Review of substitutions/clarifications will be at the discretion of The Daimler Group, Inc.
