State of Ohio Seeking Small Businesses to Hire Export Interns

The State of Ohio will reimburse 50 percent of intern wages.

Are you a business interested in selling your products or services internationally? The Ohio Development Services Agency is searching for companies who are interested in exporting their products into international markets.

The Ohio Export Internship Program provides a unique opportunity to businesses interested in exporting by matching them with highly-motivated college students who have taken export-focused coursework. This year, 50 students from 12 different Ohio universities have been selected to participate in the program.

"Our students can help Ohio businesses take their quality goods and services to international markets they couldn't otherwise reach," said David Goodman, director of the Ohio Development Services Agency.

The Ohio Development Services Agency offers participating small to medium-sized businesses a 50 percent reimbursement for the wages of the intern.

In the five years of the program, 144 student-company matches were created, resulting in more than \$26 million in expected global sales and 25 full-time job offers to students.

The deadline for companies to apply is **March 1, 2017**. The summer internship runs from May 16 through August 11, 2017. Ohio companies can apply at www.eip.development.ohio.gov.

Motorcycle, watercraft, tractors among vehicles on sale at state auction

Approximately 220 vehicles will be up for bid at the state's next surplus vehicle auction on Saturday, Dec. 17.

The sale will feature a wide variety of cars, trucks, vans and miscellaneous vehicles, including a selection of four-wheel drive SUV's. Among the vehicles up for bid will be a 2004 Suzuki motorcycle and a 1995 Yamaha Wave Runner jet ski, as well as two tractors and an extended cab GMC drill rig.

The auction will be held at the Ohio Department of Administrative Services, General Services Division headquarters, 4200 Surface Road, Columbus, 43228. The gate opens at 8 a.m. and the auction begins at 9 a.m. The lot will remain open until 5 p.m. on the day of the auction. To view all of the vehicles up for bid,

Vehicles may be inspected between 8 a.m. and 3 p.m., Monday, Dec. 12 through Friday, Dec. 16. Vehicles may be started only between 8 a.m. and 2:45 p.m. on Friday, Dec. 16.

All vehicles are sold "as-is" with no warranties. All vehicles must be paid for in full the day of the auction. Cash, credit and debit cards (Discover, MasterCard and Visa) are accepted. There is a 3 percent service fee on all credit and debit card transactions. Temporary tags are no longer available at state surplus vehicle auctions.

City of Columbus amends Title 39 of City Code

On December 12, the City Council of Columbus amended Title 39 of City Code. Title 39 governs Affirmative Action for the municipality. The changes to Title 39 have replaced the Office of Equal Opportunity with the Office of Diversity and Inclusion (ODI).



Additionally, the amendments expand the codified definition of minorities to include Hispanic Americans, Asian Americans, and Native Americans. This is now in compliance with the US Equal Employment Opportunity Commission. ODI has been tasked with ensuring, workforce and supplier diversity as well as contract compliance and diversity outreach.

Furthermore, ODI will be responsible for Minority, Female, and Veteran Business Enterprise Certification, which will allow for certified enterprises to participate in the business networking and educational programs. Lastly, ODI will be trusted in implementing future unified goals based on the results of the 2017 disparity study.

"We feel the new amendment is a positive change for minority owned businesses," said Stephen Francis, Chief Diversity Officer for the City of Columbus. "The changes will allow us to provide services and support to these businesses from the City. We want to certify as many minority businesses as we can to offer a wide variety of options for city departments to do business."

Advocate for your business in 2017

United we are stronger! I think 2017 is going to be telling for Black businesses. Are we going to stand up to entities that accept our taxes dollars and demand our fair share of purchasing budgets or are we going to allow business as usual. Our votes and dollars have power. Are we going to allow inclusion and diversity efforts to become obsolete? Black businesses matter. Black folks pay taxes. Public school districts receive local, state and federal funding because Black students are enrolled. Unfortunately, Black businesses are not getting their fair share of business with public schools. With the exception of Columbus City Schools, I can not convince area public schools to participate in the OhioMBE Procurement Fairs. They are not mandated to provide purchasing opportunities, practice good faith efforts or access to opportunities so they don't. While local schools are eager to accept tax dollars from a diverse population, they are less than receptive to providing economic opportunities for businesses of color.

Columbus City Schools, the state's largest public school district, touts its inclusion program, but are they really serious about including disadvantaged businesses in the purchasing scheme? The purchasing numbers speak loud and clear. They are not.

Has Columbus City Schools ran a fast one the voters? Voters recently gave the school district a vote of confidence and support by passing a permanent school tax levy. For four straight years, they have failed to meet the board policy of purchasing 20 percent of goods and services with certified LEDE businesses. Why can't they meet the purchasing goal? If folks jobs were tied to meeting the goal, the goal would be met! It appears that since its just a goal, they are lackadaisical about it. The voters gave them the money they requested. Now what? What leverage do Black businesses have? I guess challenge the elected school board to require purchasing inclusion and meet the goal or run the risk of not being re-elected. Why is the board approving purchasing legislation that does not have inclusion? They set the tone. Former board president Stephanie Hightower would send legislation back and demand inclusion. Purchasing requests brought before the board would not be honored without including disadvantaged businesses.

The purchasing numbers are posted on OhioMBE.com. I'm still waiting for the board president to reschedule the meeting he canceled. His silence on the matter is acceptance of the situation. I encourage you to get active! Make phone calls. Write letters. Action is obviously necessary and required. Advocacy is imperative. Your voice is needed! United we can make a change.



Your Company's Charitable Giving

Giving is its own reward" said social activist Dorothy Day, but the tax law also provides some benefit to those who give. At this time of the year, attention to charitable giving is more important than ever because there are so many individuals who have suffered from disasters this year; others continue to face economic challenges and still others just need a helping hand during the holiday season. Here's how your business can help those in need, and what you can gain tax wise.

Giving cash - Cash donations, which includes donations by check, credit cards, and electronic transfers, is the most common type of donations. You can deduct the amount given to IRS-recognized charities. Use the IRS's Search for Charities to make sure the organization you're donating to is tax-exempt. You cannot deduct gifts directly to an individual, no matter how needy the person may be.

Owners of pass-through entities report their share of the company's donations on their individual returns. Cash donations are deductible by those who itemize up to 50% of adjusted gross income. Donations by C corporations are limited to 10% of taxable income.

Giving inventory - Giving inventory may benefit the charity as well as your business. You can, for example, dispose of excess or obsolete inventory (that still has value), which is still very useful to a charity. Tax-wise, your donation is limited to your tax basis (typically your cost) if the fair market value of the property is greater.

C corporations. Donations of inventory items to a charity that cares for the ill, the needy, or infants receives an enhanced donation. This is your basis (cost), plus one half of the profit that would have been recognized if you'd sold the inventory at its fair market value. The deduction, however, cannot exceed two times your basis.

Food inventory. For all types of entities there's also a similar enhanced deduction for donations of apparently wholesome food. Again, the donation must be made to an organization that uses it for the care of the ill, the needy, or infants.

Encouraging employees - If this is a slow time of the year for your business, consider giving employees time off. While you can't require them to use the time for charitable purposes, you can encourage them to do so. For employment tax purposes, this paid time off is treated as any other compensation.

You cannot deduct the value of your time. So, for example, if you have an electrical business and do wiring for a local charity, you cannot deduct what you would have charged for labor. However, any materials you use for this activity is deductible as an unreimbursed out-of-pocket expense.

Other ideas - The actions you and your staff can take to benefit charities are endless. Here are some ideas:

 Participate in local charitable activities, such as being a drop-off point for Toys for Tots.

- Hold a blood drive. During the holiday season, local blood banks routinely find themselves short of blood and can use the donations.
- Attend fundraisers. Your donation is limited to the amount that exceeds the benefit you receive.
- Leave-based donations.
 Set up an in-house fund
 to which employees can
 donate their unused vacation, sick, and personal
 days. These unused days
 can then be used by an
 employee in need. Generally, the donated leave
 time is still taxable compensation to employees,
 and subject to employment taxes. However,
 from time to time the IRS
 let's employers donate

the unused leave time to charities benefiting victims from specific disasters, such as the <u>Louisiana floods</u> and <u>Hurricane Matthew</u> this year. If so, employees aren't taxed on their donated leave time and the company gets a charitable contribution deduction.

Final thoughts - If you give any money or property, be sure to properly substantiate the donation if you want to claim a write off. You must receive a written acknowledgment for a donation of \$250 or more and retain checks or other proof for a smaller donation. 




