

### Secretary Husted: 2017 Sets Record For New Business Filings In 11 Months

Ohio Secretary of State Jon Husted recently announced that with 8,558 new entities filing to do business in Ohio throughout the month of November – 826 more than in November 2016 – 2017 marks another record-setting year for the number of new business filings with a month still to go. To date, 108,547 new entities have filed to do business this year – exceeding 2016's total by more than 3,500.

"The word is out, we've made it easier than ever to start a business and as a result more and more entrepreneurs are choosing Ohio as the place to set up shop," said Secretary Husted. "Not surprising when you consider all we have done to reduce processing times, cut filings fees, and improve customer service."

Much of this success has been possible because of Ohio Business Central, the online business filing site founded by Secretary Husted in 2013. Due to the efficiency of Ohio

# publisher's note

### **Happy 2018**

Happy 2018! As you reflect on last year and embark on 2018, what are your goals?

How will you grow your business? How will you exercise political power? How will you empower our community?

Last year, the themes of my columns were "Advocate! Resist!" The political and economic climate required us to take action. We still have major work to do. I am hopeful. The resistance has been successful. We can't let up. Black women across the country challenged decision makers and made a difference. Black women are politically a powerful force. Black women have had a higher voter turnout rate than any other racegender subgroup in the 2008 and 2012 presidential elections.

"Black women have been attempting to save America since the dawn of time," said Democratic strategist Symone D. Sanders in an interview with Newsweek.

In 2017, U.S. Congresswoman Maxine Waters, reclaimed her time and demanded answers regarding the financial actions of the President. U.S. Senator Kamala Harris vigorously and with authority questioned Attorney General Jeff Sessions and Deputy Attorney Rod Rosenstein during Senate intelligence committee hearings on the Russia investigations. U.S. Congresswoman Frederica Wilson stood up and defended fallen hero U.S. Army Sergeant La David Johnson and his family. ESPN Sportscaster Jemele Hill boldly called out the racists actions of Donald Trump. Journalists April Ryan and Joy-Ann Reid routinely ask difficult questions and confronted elected officials.

Black women in Alabama exercised their right to vote and prevented an accused child sexual predator from holding a seat in the U.S. Senate. Tarana Burke started the #MeToo movement 10 years before it became the 2017 mantra of women who were sexually harassed or assaulted.

On the local front, Black women too are making a difference. Nana Watson, president of the Columbus branch of the NAACP, is challenging government and local entities to be more inclusive in hiring Black employees and utilizing Black-owned businesses.

Damita Brown (City of Columbus), Terri Wise (Columbus City Schools), Kiana Simmons (Ohio Department of Rehabilitation and Correction) and Andrea Quinichett (Columbus Metropolitan Housing Authority) are using their talents and voices to improve purchasing opportunities for Black businesses.

Kamilah Prince, National Director of African American Engagement for the Republican National Committee will be in Columbus on Saturday, January 20, 2018 at the Ohio Republican Party, 211 S Fifth Street, to host a roundtable discussion on African American engagement in Ohio and provide leadership training.

Republican Leadership Initiative Training is an intensive training program designed to bring volunteers and activists to the next level and to recruit and train the next Republican field operatives. Using state-of-the-art walk application, volunteers and activists will receive advanced training in door-to-door canvassing. Volunteers and activists will become experts in voter registration, volunteer recruitment, data and targeting, as well as social media.

RLI trains volunteers to be the next group of leaders in their communities. Prior to the RLI Training, we will hold a roundtable discussion on African-American engagement in Ohio. The roundtable portion will start at10:00am. Register at http://bit.ly/2CrsG0R

Business Central, three out of every four new businesses are now started online.

From the time Ohio Business Central was launched until the end of November 2017, the Secretary of State's Office has processed 318,071 online filings. In August of this year, Secretary Husted announced that 100 percent of all filings needed to start or maintain a business in Ohio may now be submitted online.

### State offers tax penalty forgiveness program

The Ohio Department of Taxation announced it will be offering a tax amnesty program from Jan. 1 to Feb. 15. The program allows individuals and businesses with unreported or underreported income to come clean with tax liabilities. If consumers and businesses pay all of those delinquent taxes, they will owe no penalty charges and only half of the interest charges they would normally be assessed.

The amnesty program was last offered in 2012.

"The Ohio Tax Amnesty is a tremendous opportunity for eligible taxpayers to address an unreported tax debt and eliminate the financial risk of not complying with the obligation to file and pay taxes," said Ohio Tax Commissioner Joe Testa. "If we all comply with the tax laws, as most Ohio taxpayers do already, we can lower the tax rates for all taxpayers."

This program covers issues such as unfiled returns, unreported income or underreported income.

During the program in 2012, Ohio collected \$30.5 million.

The amnesty program includes the following taxes: individual income tax; school district income tax; employer withholding tax; employer withholding for school district income tax; pass-through entity tax; sales tax; use tax; commercial activity tax; financial institutions tax; cigarette and other tobacco products taxes; and alcoholic beverage taxes.

# Get Ready for Taxes: Filing Electronically a Safe, Easy Way to File

WASHINGTON – The Internal Revenue Service said today that it expects more than 90 percent of all 2017 individual tax returns to be prepared using tax software. The majority of those will be e-filed. Since 1986 when the IRS started accepting electronically filed tax returns, more than 1.8 billion have been securely processed.

The IRS urges taxpayers to wait until they have all the forms and documents needed before preparing a tax return. Most documents arrive before the end of January. This includes Forms W-2 from employers and Forms 1099 from banks and other payers. Those claiming the Premium Tax Credit need Form 1095-A from the Marketplace. Not having all required documents may cause a return to have an error that delays processing and therefore, delays the refund.

Taxpayers have options to prepare and e-file a return:

- IRS Free File, free brandname software for taxpayers with incomes below \$66,000 (http:// bit.ly/2C4eaMx)
- Commercial tax preparation software,
- Volunteer Income Tax
   Assistance and Tax Counseling for the Elderly programs, sites with IRS-certified volunteers
   (http://bit.ly/2BPVJXO),
   or

 Tax professionals. Tips for choosing a return preparer and details about national tax professional groups are available on IRS.gov.

The IRS2Go Mobile App (http://bit.ly/2pQwdQC) can help find free tax preparation assistance, check a refund status and more.

Taxpayers should keep copies of their most recent tax returns. Taxpayers using a software product for the first time may need their Adjusted Gross Income amount from their prior-year return to verify their identity. Taxpayers can learn more about how to verify their identity and electronically sign tax returns at Validating Your Electronically Filed Tax Return.

### Faster Refunds with Direct Deposit

Choosing e-file remains the safest way to file an accurate income tax return and combining it with direct deposit is the fastest way to receive a refund. In 2017, more than 88 million tax refunds worth over \$260 billion were directly deposited into taxpayer's bank accounts.

In 2018, the IRS again expects to issue more than nine out of 10 refunds in less than 21 days. However, by law the IRS cannot issue refunds if the return claims the Earned Income Tax Credit or Additional Child Tax Credit before mid-February. The change applies to the entire refund and helps ensure that taxpayers get the refund they are owed by giving the IRS more time to help

# Minority-owned subcontractors starting to take advantage of ECDI's innovative "Capital For Construction" program

ECDI's Jesse Mark, who has worked within the businessfinancing sector for 17 years and was recently hired by ECDI to oversee the program, sat down to give us an update on the first six weeks since the program's official launch.

### How is the "Capital For Construction" program going so far? What sort of progress have you made since it launched?

To date, \$363,000 has been accessed by minority-owned subcontracting companies through this program. Funding has gone on to support a number of services including final clean, electric, painting, metal framing, landscaping & lawn care, and carpentry. These funds have helped our clients pay for labor and material costs; but we can also provide funding for working capital, equipment financing, and extend clients a line of credit.

### Who is the ideal candidate that could take advantage of the financial products offered through the program?

Any MBE certified contractor who is looking to hedge against their receivables for outstanding projects. Those with a proven track record of successfully completed projects are more likely to get funded. But primarily, I am looking for clients with excellent character that operate a company that is looking to grow and create jobs in our community.

### Aside from the lending products, what else can this program offer to subcontractors?

We have developed a training curriculum in conjunction with the MBE program; classes will commence in early 2018. Classes will cover items such as estimating, bidding process, payroll & cash flow management.

### What are some of the initial challenges you've faced getting the program off the ground?





### **Get Your Workspace in Shape for 2018**

While many small business owners may be relaxing this week between Christmas and New Year's, I'm getting a jump on 2018 by decluttering my office. I'm usually okay with a little clutter, but between traveling and the holidays, the mess on my desk is making it hard to be productive.

If this sounds all too familiar, here's a plan to help get your workspace organized for the New Year.

- 10. If you're ready for a real change, consider moving some

- 11. Do your printers, copiers, multifunction devices and other office equipment need to be cleaned? Check the manuals before you get started; you don't want to accidentally break something.
- 12. Is anything in need of repair or replacement? Get it done
- 13. This is actually a great time of year to find deals on office supplies.
- 14. Clear your computer's cache at least once a year (if not more often).
- 15. How many emails are in your inbox? Create folders in your email system, and move the appropriate emails to them.
- 16. Do you have a computer cleaning app? Clean your computer annually.
- 17. Get rid of apps you're not using (properly uninstalling them,) and delete bookmarks you no longer use. Do this on your mobile devices as well.
- 18. If your computer is sluggish when starting up, check the apps that launch when you turn on your computer.

Sandra Madison was born in Baltimore, Maryland and graduated from Northwestern High School in the 11<sup>th</sup> grade with honors and was accepted on scholarship at the University of Maryland College Park. During the summer after high school graduation, she was accepted at Harvard University Graduate School of Design's Career Discovery Program for Urban Design. This program crystalized her decision to apply to the School of Architecture within the University of Maryland, College Park. In her senior year, Sandra was invited to speak as Valedictorian to her graduating class and was the only African American Architecture graduate in her class.

After 10 years of working in Architectural Firms in Baltimore, Sandra moved to Cleveland to worked with Robert P. Madison International, Inc. (RPMI) where she worked for 26 years before becoming majority Owner with title CEO, Chairperson. Today, RPMI is the largest black female owned architecture firm in the State of Ohio. It should be noted that only 2% of all licensed architects are black and only 18% of all licensed architects are female.


