While studying product design at the Ohio State university, five product designers banded together after being dissatisfied with current protein shak-

ers on the market and set out to develop a better product; all while balancing school, part-time jobs and senior thesis.

After spending year working on the design and shortly after graduating, they launched TITAN Mixer Bottle in May 2015 via Kickstarter and raised \$82,000 which they used to start production. A year later, they received their inventory and

How to Recover from **Business Setbacks**

February 11 is "Don't Cry Over Spilled Milk Day." What better time for entrepreneurs to come to terms with the fact that setbacks happen—and that wallowing in them serves no productive purpose?

Consider these 5 ways to get over and beyond the disappointment of a business setback.

1. Acknowledge and accept it.

Going into denial or letting your pride get in the way of owning up to a business mistake or failure will only make matters worse. Take a deep breath, and accept that sometimes things go wrong. Realize that when humans are involved in anything, there's the potential for human error. It's OK to feel frustrated, but avoid pointing blame at yourself or others. Take responsibility, and then hold your head high as you take the steps needed to turn things around.

2. Put it into perspective.

Many people get into the habit of blowing problems out of proportion. Before going into "the sky is falling" mode, take a step back to assess how significant the predicament is in the grand scheme of things. Is it a financial loss that is going to affect your ability to pay your vendors? Is it a product flaw that has created a brand image problem? Is it a contractual issue that could cause legal troubles? Instances like those demand urgent action, but not every setback you face will put you in dire straits. Evaluate the impact before

jumping into crisis mode. 3. Don't dwell; direct your attention toward determining what went wrong and fixing it.

Feeling sorry for yourself won't help the situation. Put your emotions aside, and objectively evaluate the cause of the setback. Was it due to unclear language in your agreement with your customer? Was it because your customer service staff didn't have proper training? Was it because you failed to do enough market research? Immediately start laying out what you will change to ensure it doesn't happen again. This may require enlisting the help of professionals who specialize in certain business disciplines, such as human resources, law, finances, taxes, public relations, etc. Make sure you develop a clear plan for what needs to be done differently, and share it with your team so everyone is on the same page.

4. Embrace it as a learning moment that will make your business stronger.

As Malcolm Forbes once said, "Failure is success if we learn from it." As devastating as business speedbumps might be, they can benefit you in the long run. The key is to look beyond your dismay, and use the newfound wisdom gleaned from the experience to improve your company. For example, losing a key client that results in you implementing a customer loyalty program will help you retain clients—and the revenue they bring to your bottom line. And making a



Business Profile: Kamala Colbert

Kamala Colbert has her eyes on the horizon, always looking for new experiences and new ways to look at the world. Kamala's path to entrepreneurship was long and complex but it was this attitude that helped her succeed. Kamala grew up in Akron, Ohio, but moved to California as teenager. "That experience opened up my eyes. I realized there is larger world than Ohio with many opportunities." That eventually helped push her to pursue starting her own business.

After her California adventure, Kamala returned to Akron and graduated from Firestone High School. She then attended Hondros Community College where she took courses in real estate. Still not quite sure what she wanted to do, Kamala also studied to be a medical assistant at the American Technical College. Her life went in a sudden challenging direction when she was incarcerated, spending 6 years in prison. But Kamala used this unfortunate turn of events to her advantage, writing, directing and acting in plays while she was incarcerated. Shortly after her release, she enrolled in ONOW, a training program specifically for women hoping to work the construction field. The program sparked her interest in construction and painting and planted the idea that would eventually become her business.

Kamala found that entering the workforce after her incarceration was harder than she had expected, and that "it was almost impossible to find steady work after being incarcerated." After a few years of scraping by with odd jobs, Kamala knew it was time to go out on her own and in 2006 she started Colbert Painting. "At the beginning it was just me, a bucket of paint, and a paint brush". Kamala relied on her community to get her business off the ground, painting houses in her neighborhood on the East side of Columbus. She was able to leverage her community connections to be paid in advance for many of these jobs, allowing her to grow her business without having to invest large amounts of capital up front. Emboldened by her early success, Kamala began going for bigger commercial projects and landed contracts with Columbus City Schools and The Ohio State University.

By 2015 Kamala's company had begun to plateau, and it became clear that she could not grow her business working all on her own. To get bigger projects she would have to grow her

team and secure more capital to pay for supplies. This issue became urgent when she got the opportunity to bid on a \$70,000 project with the Hilliard Library. To complete the project she would have to hire a full time employee and raise the capital to buy the necessary supplies, something she could not do on her own. Through friends and community leaders she heard about ECDI's Capital for Construction



Program that addresses the financing gap minority-owned construction subcontractors face when submitting bids for largescale construction contracts. She secured a loan and with ECDI's support, she was able to win the project. Kamala has since hired a full time employee and is hoping to hire more in the future.

In addition to enrolling in ECDI's Capital for Construction Program, Kamala became a member of ECDI's Women's Business Center and participated in this year's Project Reimagine Program, a female focused training series that has been proven to help existing business grow and reach new heights.

Kamala still writes her own plays and performs as a member of Urban Arts Theater Company.
