Interim Superintendent seeks improvement in academics and purchasing

A true champion of public education in Central Ohio for more than two decades, Dr. John D. Stanford is the Interim Superintendent of Columbus City Schools, managing the operations of Ohio's largest school district and advancing the academic achievement of its more than 51,500 students.

Dr. Stanford was appointed Interim Superintendent by the Columbus Board of Education, starting in January 2018, having served as Deputy Superintendent for more than five years and more than three years as the District's Chief Operating Officer.

During that time, Columbus City Schools has increased access to high quality pre-Kindergarten experiences, served more students with Limited English Proficiency and Special Needs than any other district in the region, eliminated the achievement gaps in 26 of our schools, provided a greater return on taxpayer investments by reducing administrative overhead, and implemented digital and physical data review systems to

provide constant updates on vital student-related data measurements.

Throughout his service, Dr. Stanford has shared a desire to see the District's purchasing and contracting of services reflect a more diverse vendor pool.

"Columbus City Schools is a very inclusive and diverse school district grounded in sound Board Policies that encourage and support inclusive business practices," said Dr. Stanford. "We believe that our inclusive business practices are contributing to the larger inclusive and diverse economic market in the Central Ohio region."

The District has nearly doubled overall participation in its Local Economically Disadvantaged Enterprise (LEDE) program over the past three years. The District has also steadily increased the percentage of contracted dollars invested with LEDE-participating companies, doubling the percentage over the past four years to nearly 14%.

"There is a commitment from the Board and our leadership team to see even better numbers," Dr. Stanford added. "Our inclusive business practices start with our Office of Outreach Services

cluding the development of a small business incubator. Under his leadership, that center rose from a local program to a national model for community economic development, particularly among Historically Black Colleges and Universities.

5 Reasons to Hire Your Child

Nepotism—the practice of using power or influence to favor relatives—has a poor connotation. However, when it comes to your business, it may just be a great idea, especially in today's environment. Here are 5 reasons why.



1. Talent in a tight job market. With unemployment rates at record lows, many businesses are now struggling to find the employees they need in order to grow. NFIB reported that 31% of owners had jobs they couldn't fill. If you find yourself in this position, think about whether your child can fill an opening in your company. Depending on your child's age and talents, the spot may be part-time, seasonal, or full-time.

If your child is young, be sure to check on state child labor laws. These laws set the minimum ages, maximum hours, coordination with school, and a ban on hazardous work. Under federal law, children younger than 16 years of age working in nonagricultural employment in a business solely owned by their parents, may work any time of day and for any number of hours. So, your 14-year old can do data entry in your home-based business. However, parents are prohibited from employing their child in manufacturing, mining, or in any other hazardous activity. You can see an overview of child labor laws at the U.S. Department of Labor.

 Experience. Putting your child to work in your company gives him or her helpful experience in the business world. This resume-type work can help your child seek employment elsewhere after graduation if this is what they want.

If the job you need to fill requires training, why not train your own child to do it?

3. Tax-free income. Earnings up to the amount of the standard deduction for your child's filing status (typically single) are tax free. For 2018, this means that there is no federal income tax on earnings up to \$12,000. And your business gets to deduct the wages, which must be reasonable for the work performed. Overall, this means more money within the family.

And there may be payroll tax savings for the business as well. If your business is unincorporated (a sole proprietorship, partnership, or limited liability company):

- **Payments for the services of your child under age 18 are exempt from FICA taxes
- **Payments for the services of your child under age 21 are exempt from FUTA taxes

can also establish its own individual business credit file and score.

Credit Capacity – Your personal credit worthiness is based on your ability to pay your financial obligations such as credit cards, student loans, auto loans, mortgages etc. Your personal credit capacity is impacted by many variables including but not limited to debt to income ratio, new credit, payment history, credit utilization, credit limits, and inquiries.

With small business credit; a company's credit capacity is based on factors such as company revenues, years in business, tangible and intangible assets, credit card transactions, payment history, industry classification, credit limits, inquiries, and a host of others.

Credit Ratings – The most popular credit scoring system used for personal credit are FICO® scores. According to Fair Isaac, 90% of "top" U.S. lenders use FICO® scores.

However, with business credit there is no single uniform risk assessment model used by banks, suppliers, vendors and retailers. Instead, various risk assessment tools and scoring systems are used such as FICO® SBSS, Paydex®, Intelliscore, and the Small Business Credit Risk Score.

As you can see there are major differences between business credit and personal credit. As a business owner it's vital to invest the time in building your small business credit. Ultimately, a strong business credit report and score will enable a company to acquire credit and financing based on its own creditworthiness with favorable rates and terms.

led by Terri Wise, a highly trained and skilled team member who has worked for the district for more than a decade to provide equal opportunity and access to the District's business prospects."

"Through the leadership of Ms. Wise and Mr. Maurice Oldham, our Chief Operating Officer, I envision Columbus City Schools building on the existing successful programs to achieve a higher level of success."

Over the past three years, the Business and Operations team has taken a number of steps to encourage greater participation in the LEDE program, including: eliminating the requirement that companies acquire business insurance before submitting a bid; increasing the points on a Request for Proposals (RFP) that are allotted to LEDE participation; and hosting a procurement fair for all certified LEDEs to meet with key decision makers in the District.

OhioMBE Certification 101 at the WBC

Make a resolution to get your business certified in 2018!

There are several reasons why you should get your business certified:

- 1. Some entities have purchasing goals. Only certified businesses can participate.
- 2. Certification adds legitimacy to your business. You have gone through a process that has determined that your business is owned and controlled by a minority, woman or disadvantaged business.



- 3. Certification can afford you loan and bonding opportunities. The State of Ohio has loan and bonding programs specifically for certified minority owned businesses.
- 4. Certification can be a marketing tool for your business. You can add your certifications to your marketing materials, business cards, website, etc. Many consumers like during business with veteran, minority or woman owned businesses.
- 5. Certification can be used in the private sector. Many companies don't have a certifying program but in an effort to have supplier diversity, will accept the certifications from some governmental agencies.

Wages are still subject to income tax withholding unless the child claims exemption from it. The IRS has not yet announced the rules for claiming exemption from income tax withholding for 2018, but says it's working on a revised Form W-4, which is the form used for claiming an exemption.

4. Retirement savings. No matter how young your child is, it's not too early to begin saving for retirement. As long as a child has earned income—such as wages from working for you—a contribution can be made to an IRA; there is no minimum age requirement. For 2018, the contribution limit is \$5,500, but no more than 100% of earned income. Thus if your child earns \$4,000, the contribution limit is \$4,000.

Given the long time before retirement, it may be better for your child to forego a tax deduction in a traditional IRA in favor of creating tax-free income through a Roth IRA. And, even if your child spends some or all of his or her earnings, you can make the contribution on the child's behalf (up to the earnings limit).

5. Succession planning. According to a survey a few years ago, 29% of business owners expected to exit within 5 years, and 54% within 10 years. That same survey found that 37% of business owners wanted to transfer the business to a family member. If you're contemplating retirement any time soon, or just want to be prepared to keep the business within the family in the future, then grooming the next generation now to take over down the road is

Previously, Dr. Stanford served four years as the top education advisor to Ohio Governor Ted Strickland, helping to develop and implement the Governor's annual education budget of almost \$11 billion. Dr. Stanford has taught at The Ohio State University's John Glenn School of Public Affairs; championed the leadership roles of the state's school board members at the Ohio School Boards Association; and served Columbus City Schools as Supervisor of Legislative Services and Special Assistant to the Superintendent for Board Services and Government Affairs.

For his leadership in education advocacy, Dr. Stanford earned a 2015 Ohio School Boards Association Central Region Exemplary School Employee and the 2009 Ohio University College of Education Samuel I. Hicks Executive-in-Residence awards. He's an alumnus of Leadership Columbus and serves on the Boards of the Franklin County Children's Council and Franklin County Family and Children's First Council. He's also the founding President of the 100 Black Men of Central Ohio and an inactive member of Kappa Alpha Psi Fraternity, Incorporated.



Tips for starting a business

- 1. **Do the prep work.** Find a mentor, someone you know who could guide you along your new path. If you're lacking skills in marketing or finance, sign up for a community college or certification program.
- 2. **2. Spend a lot of time talking to your future customers**. You need to really learn what their needs are and what their wants are. You're letting people know you are going to be starting a business. Conversing with them will help you learn about positioning and how to address the market.
- 3. Write a business plan. In general, a simple plan which you'll have to submit to get financing should be about 20 pages. Your business plan will include a summary of what your company will do, who the customers will be, why you are qualified to run it, how you'll sell your goods and services and your company's financial outlook.
- 4. Line up sources of funding. Most startups are funded with personal savings. It's advisable to set aside at least six months of fixed living expenses, though. Try not to dip into your retirement savings; you'll be subject to withdrawal penalties and income taxes and will lose the tax-deferred compounding that could serve you well in retirement.
- Pay attention to your accounting and taxes. Learn to use software such as QuickBooks.
