### You can register to vote online

To register online you will need to provide the following:

- Ohio driver's license or Ohio identification card number
- Name
- Date of Birth
- Address
- Last four digits of your Social Security number

If you do not have any portion of the required information, you must use the paper form. You can get a copy of the form online at http://bit.ly/2EdjPfk. Once you complete this form, you must sign and send it to your county board of elections.

If you are a Safe at Home participant, before you proceed, please call the Safe at Home office at 614-995-2255.

#### **REGISTRATION DEADLINES**

You must register or update your voter registration no later than 30 days prior to an election. Upcoming voter registration deadlines:

- April 9, 2018 for the May 8, 2018 Primary and Special Congressional Primary (12th Congressional District) Election
- July 9, 2018 for the August 7, 2018 Special and Special Congressional General (12th Congressional District) Election
- October 9, 2018 for the November 6, 2018 General Election

Quincy successfully ran his financial services business for over ten years. 

#### **BACKGROUND:**

The Mid-Ohio Regional Planning Commission (MORPC) issues daily air quality forecasts and notifies the public when ozone and particle pollution levels are considered to be unhealthy for sensitive groups of people. MORPC uses the national Air Quality Index (AQI) scale to inform the public about daily ozone and particle pollution levels. The AQI scale runs from 0 to 300 – the higher the AQI value, the greater the health concern. When levels reach above 100, air quality is considered to be Unhealthy for Sensitive Groups. MORPC issues an Air Quality Alert to the public when pollution levels reach 101 or higher.

#### **SCOPE OF SERVICES:**

MORPC is seeking a quote on a media campaign to help increase awareness of MORPC's Air Quality Alert service, increase subscribers to email notification database for Air Quality Alerts, educate the public about what to do when an alert has been forecasted and what sensitive groups (people with respiratory illnesses, seniors and children) should do to protect their health, and reduce individual contributions to air pollution. The media campaign will run from June 1 – August 31, 2018, with lead time to develop the campaign elements beginning in May.

## Updated Withholding Calculator Reflects Changes in New Tax Law

To help taxpayers, the IRS updated the special Withholding Calculator tool on IRS.gov to reflect changes in the Tax Cuts and Jobs Act passed in December.

With most employees seeing withholding changes in their paychecks, the IRS recommends taxpayers use the Withholding Calculator to do a "paycheck checkup." This will help taxpayers ensure they are having the correct amount of income tax withheld from their paychecks.

Doing a checkup can help protect against having too little tax withheld and facing an unexpected tax bill or penalty at tax time in 2019. Some taxpayers might prefer to have less tax withheld up front and receive more in their paychecks, which would reduce their tax refund next year.

The IRS encourages everyone to check their withholding as soon as possible, but it's especially important for these people to use the Withholding Calculator to make sure they have the right amount of tax withheld:

- Two-income families
- People with two or more jobs at the same time or who only work for part of the year
- People who claim credits such as the Child Tax Credit
- People who claim older dependents, including children age 17 or over.
- People who itemized deductions in 2017
- People with high incomes and more complex tax returns
- People with large tax refunds or large tax bills for 2017

Remember, the Withholding Calculator does not ask the user for personally identifiable information, such as name, social security number, address, or bank account numbers. The IRS does not save or record the information the taxpayer enters in the calculator.




