# Senator Charleta Tavares seeks to expand contracting opportunities with SB 15

The Ohio Legislative Black Caucus has an extensive history when it comes to increasing support for minority businesses. It is not uncommon to see our institutions of higher education that are not state institutions sometimes forgotten when it comes to setting diverse business practice requirements, yet OLBC member, Senator Charleta Tavares has taken notice. She began the 132<sup>nd</sup> general assembly with introducing Senate Bill 15 which would expand minority business set-asides to community colleges, state community colleges, technical colleges, and university branches.

SB 15 makes it mandatory that community colleges, state community colleges, technical colleges, and university branches comply with minority business enterprise set-aside requirements, and additionally require the Director of Administrative Services to establish guidelines

for such entities. This would increase the number of contract opportunities whether it be construction or additional services provided for these institutions by minority entities. Current Ohio law requires that state agencies set-aside 15 percent in each fiscal year for goods and services contracting opportunities exclusively for certified minority businesses. All state universities and the Northeast Ohio Medical University are currently under MBE requirements but there are at least twenty-six community colleges in the state of Ohio that aren't subject to such requirements due to their non-state agency status.

Additionally, SB 15 requires an expansion of participation with the EDGE program to these non-state institutions of higher education. EDGE stands for Encouraging Diversity, Growth, and Equity. It is a program designed to increase business opportunity for those owners who would traditionally be considered socially or economically disadvantaged. Business enterprises who can fall under EDGE are those businesses that are certified by the Department of Administrative Services as being owned and controlled by U.S. citizens who reside in Ohio and as being socially and economically disadvantaged, based on certain criteria. SB 15 would require the Director of Adminis-

The Federal Government Achieves Small Business Contracting Goal for the Fifth Consecutive Year with Record-Breaking \$105 Billion to Small Businesses

Eight Federal Agencies Receive A+ Rating on the Procurement Scorecard

**WASHINGTON** – The U.S. Small Business Administration announced that the federal government met its small business federal contracting goal for the fifth consecutive year awarding 23.88 percent in federal contract dollars to small businesses totaling \$105.7 billion, an increase of \$5 billion. This marks the first time more than \$100 billion in prime contracts has been awarded to small businesses. The federal government earned an "A" on this year's government-wide scorecard.

"I am happy to report that for the fifth consecutive year, the federal government has not only met and exceeded its small business contracting goal, but it has awarded \$105 billion to small businesses for the first time earning the government an A on SBA's scorecard for this remarkable achievement," said SBA Administrator Linda McMahon. "This grade reflects significant efforts by federal agencies toward meeting the 23 percent statutory goal to award prime contracts to small businesses. Every contract that gets in the hands of a small business owner is a win-win for the business, creating jobs in their communities, and boosting the nation's economy."

### Five Factors that Impact Your Business Credit

When it comes to business credit, there's no standard scoring model for assessing risk. Lenders, suppliers, banks, leasing companies, businesses, and finance companies all use different reports and scoring models depending on which business credit reporting agency they subscribe to.

Your company's business credit report shows banks, lenders, suppliers, vendors, and other businesses how your company handles its financial obligations. Here are five factors that impact your business credit.

**Creditworthiness.** Lenders have to believe that a business and its owners are reliable and can be depended on to repay on a loan, business line of credit, etc. The personal credit reports of an owner(s) and business credit reports of the company are the primary tools used to assess creditworthiness. In addition, trade references will most likely be required on a business credit application as part of the credit decision making process. Typically, a credit application for a business will ask for three trade references.

Before applying for business credit, it's important to evaluate both your personal and business credit files for accuracy. Be sure to clear up any issues or outdated information as soon as possible.

**Credit Capacity.** This is an evaluation of your company's ability to repay on a loan or business line of credit. This includes positive cash flow, bank history, payment history, and additional cash sources and reserves. The best way to show your credit capacity is with positive cash flow, a favorable bank rating, and positive payment history with other businesses. When it comes to payment history, banks, lenders, and suppliers want to know how long an account has been opened, the credit limit extended, and how many times the account has been paid late.

Capital Invested. One of the factors bankers use during a business loan evaluation is the amount of funds the owner has invested in the business. Most likely there will be a more favorable consideration for a business loan if there is a "reasonable" amount invested in the business from the owner.

How much skin you have in the game is very important and can make the difference between an approval and denial. Banks examine the business' debt-to-equity ratio to understand how much money you're asking for compared to how much money you have already invested in your business. The smaller the ratio the better.

Collateral. Commercial real estate, heavy machinery, business equipment, inventory, stocks and bonds, and other expensive business assets that can be sold if a business fails to repay the

Each lender considers the loan-to-value ratio differently, so you'll need to ask your lender how they intend to set that value.

Most traditional banks require collateral with a business loan, but there are other lenders who do not require any collateral to approve a loan.

Company Conditions. Be prepared to prove that the condi-

When applying for business credit, it's important to establish personal and banking relationships. It's always advantageous to apply for funding with a bank you already have an established relationship with. The less risk you pose to a bank or lender, the greater your chance of securing funding at favorable interest rates.



trative Services to adopt rules under the Administrative Procedure Act, through which guidelines would be created to allow community colleges, state community colleges, technical colleges, university branches, and the Northeast Ohio Medical University to establish procurement goals for contracting with EDGE business enterprises in the exact same way state institutions are currently required.

Here is how you can help with making Senate Bill 15 become law. After a bill is introduced it then goes on to committee. The committee that oversees SB 15 is the Senate Government Oversight and Reform committee. You can call members of that committee and let them know why you believe SB 15 is important to you and your community and urge them to support moving SB 15 out of committee. It is a small task but can have an enormous ripple in ensuring that everyone is doing their part to make sure that minority business enterprises have a seat at the table wherever the table may be present.

<u>contracting-scorecard-grading-</u> <u>methodology</u> .

In fiscal year 2017, the federal government exceeded the service-disabled veteranowned small business and small disadvantaged business goals. Prime contract dollars in all categories increased.

The federal government also exceeded its subcontract goals for awards to Women-Owned Small Business and Small Disadvantaged Businesses and awarded \$75 billion in subcontracts to all small businesses. The fiscal year 2017 prime and subcontracting awards to small businesses equate to nearly one million jobs created to support the nation's economy.

SBA continues to collaborate with federal agencies to expand small business opportunities for small business contractors to compete and win federal contracts. The FY2017 **Small Business Procurement** scorecard analyzed the prime contracting and subcontracting performance, and other contributing factors which resulted in an overall "A" grade for the federal government. Eight agencies received A+, 12received a grade of "A", three received a "B" grade and one received a "C" grade.

#### **About the Scorecard**

The annual Procurement Scorecard is an assessment tool to (1) measure how well federal agencies reach their small business and socioeconomic prime contracting and subcontracting goals, (2) provide accurate and transparent contracting data and (3) report agency-specific progress. The prime and subcontracting component goals include goals for small businesses, small businesses owned by women, small disadvantaged businesses, service-disabled veteran-owned small businesses, and small businesses located in Historically Underutilized Business Zones (HUBZones).

Every year, the SBA works with each agency to set their prime and subcontracting goals and their performance is based on the agreed upon goals. Each federal agency has a different small business contracting goal, determined annually in consultation with the SBA. The SBA ensures that the sum total of all of the goals exceeds the 23 percent target for the federal government as well as the socioeconomic goals established by law.

While each federal agency is responsible for ensuring the quality of its own contracting data, SBA conducts additional analyses to help agencies identify potential data anomalies. As part of its ongoing data quality efforts, the SBA works with federal agency procurement staff to provide analysis and tools to facilitate review of data, implement improvements to procurement systems and conduct training to improve accuracy.


## Black Female Entrepreneur Offers Words of Inspiration in New Memoir


