

State schedules two public auctions

Public auctions are the last step in the state's surplus program. State agencies declare property as surplus because it is either damaged or at the end of its life cycle for government use. In addition, property may include items seized by law enforcement officials as well as items surrendered to the TSA by airline passengers during security screening. The property is then made available to other state agencies, state higher education facilities, tax-supported agencies, municipal corporations and other political subdivisions of the state, including public schools. Remaining property is sold at the public auctions.

Great Ohioan Award nominations due Dec. 1

The Award commemorates the significant role of Ohioans in an event or series of events of lasting significance in world.

In 2003, the Capitol Square Foundation (CSF) launched the Great Ohioan Award to commemorate the significant role of Ohioans in an event or series of events of lasting significance in world, American or Ohio history. The foundation's first honoree for this award was a group of individuals which commemorated Ohio's role in the birth and development of aviation: the Wright Brothers, John Glenn and Neil Armstrong. It is fitting these Ohioans were honored in 2003, Ohio's bicentennial celebration as well as the 100th anniversary of powered flight. The foundation hosted a special dinner to pay tribute to these aviation pioneers and celebrated how they have changed our world in so many ways.

Honoree criteria:

- Must be an individual Ohioan or group of Ohioans who have made a significant or lasting contribution to the world, American or Ohio history
- Must have been born in Ohio or lived in Ohio for a minimum of five years
- At least 25 years have passed since the event, in which the nominee participated, is being commemorated
- There is a compelling reason why the Ohio Statehouse, rather than some other location in the state, should be the location of the award or commemorative work



OLBC STATEMENT ON THE HOUSE PASSING H.B. 228 "STAND YOUR GROUND"

The Ohio Legislative Black Caucus is deeply disappointed in the Ohio House of Representatives vote in favor to pass H.B. 228 in addition to the behavior of how this vote was called. "What type of message are we sending to our communities, our children, even our law enforcement? We've seen the repercussion of bills like this with the legislative justification of the murder of Trayvon Martin."

The passage of this bill sends a clear message based on the recent national narrative in stand your ground cases that black lives don't matter, our children's lives don't matter, and our community's safety does not matter. "Rather than pass legislation to eliminate the public education resource deficit or improving job opportunities for Ohioans, our republican colleagues would rather fulfill their own agenda and create an open season like environment for everyone in our communities, particularly for our children as they go to



what is supposed to be a safe haven in school." This isn't stand your ground this is "kill at will."

Furthermore, during a passionate testimony against HB 228, Representative Stephanie Howse was gaveled out of order and had her microphone cut off during her testimony as the speaker called an immediate vote. Repre-

sentative Howse had the following comment as a part of her response. "Black voices will not be silenced. We belong here, we deserve to be heard, and have a seat at the table. Republicans have been unwilling to have an honest conversation about race and the disproportionate affects their extreme policies have had on minority communities across Ohio, and sadly, we saw that playout firsthand in the 'People's House.'"

ed comprehensive supplier diversity and workforce diversity plans. The Department's supplier diversity plan included the creation of a contracting guide for businesses that are interested in working with the Department. The Department also held its own supplier diversity procurement fair in conjunction the City's Office of Diversity and Inclusion last November. The fair was attended by nearly a hundred attendees and promoted by OhioMBE. This year's Development procurement fair will take place on December 14 at

After the fair, the Department saw the benefit of a greater partnership with OhioMBE. Since early 2018, the Department has run regular advertisements in OhioMBE and has attended nearly every OhioMBE procurement fair.

A central component of the Department's workforce diversity plan is the formation of the Department's Diversity and Inclusion Committee. The committee's mission: "The Development Diversity and Inclusion Committee exists to promote a culture of awareness, understanding, respect and value. Everybody in, nobody out." The committee is comprised of staff members who have volunteered to promote inclusiveness by helping to guide the Department's annual diversity and inclusion plan, sponsoring educational activities such as quarterly Lunch and Learn events about diversity and inclusion topics, and organized a department-wide "Heritage Potluck," where participants brought in food relative to their background.
