#### Ohio recognizes three state the success and leadership agencies for creating diverse and inclusive workplaces

The Ohio Department of Administrative Services (DAS) recently recognized three state agencies for their work to create diverse and inclusive workplaces. DAS Director Matt Damschroder presented the 2019 Diversity and Inclusion Awards to the Ohio Departments of Transportation and Insurance and the Ohio Office of Budget and Management.

"The State of Ohio is a diverse state, and our goal is for that diversity to be reflected throughout our state agencies," said Governor Mike DeWine. "These awards are one way for us to recognize

among our state agencies to become a more diverse and inclusive work environment."

"The most successful organizations not only foster diverse and inclusive work environments, but also look toward the future with creative recruitment and retention strategies," said Damschroder. "Congratulations to these agencies for embracing Gover- • nor DeWine's vision for workplaces that value diversity and reflect the citizenry they serve."

The DAS Equal Opportunity Division hosts the awards program and presented them today during its biannual Diversity and Inclusion Institute. The institute is for state employees and other government entities. A panel from the Central Ohio Diversity Consortium judged submissions and selected winners in three categories based on agency size. Recipients were selected for their innovative pipeline recruitment strategies that allow job candidates and employees to learn, explore, and experience the organization at all levels:

The Ohio Department of Transportation (More than 1,000 employees) -ODOT was recognized for two apprenticeship programs. The Highway Apprentice Program provides applicants interested in highway maintenance with entry-level tempo-

#### **Ohio MLK Commission seeks award** nominations

Deadline is Oct. 11

The Ohio Dr. Martin Luther King, Jr. Holiday Commission is now accepting nominations for awards honoring Ohioans who carry on the legacy of the celebrated civil rights leader.

The Commission, with administrative support from the Ohio Department of Administrative Services (DAS) Equal Opportunity Division, will announce award winners at the annual Ohio Dr. Martin Luther King, Jr. Commemorative Celebration Jan. 16, 2020, at Trinity Episcopal Church, located at 125 E. Broad St. in downtown Columbus.

"The MLK Commemorative Celebration is a moving event that honors the remarkable Dr. King and the Ohioans he continues to inspire to this day," said DAS Director Matt Damschroder. "The event reminds us each year of our individual responsibility to carry forward the legacy of Dr. King in our state and local communities."

Nominations for each of the eight awards can be submitted electronically at das.ohio.gov/ mlk and are due by Oct. 11. There is no limit on the number of nominations one can submit.

The awards and criteria are as follows:

**Governor's Humanitarian Award:** Nominees must be individuals who act independently of associations and organizations who give their time and service freely to those in need without question and often without recognition. This award seeks to honor those quiet soldiers who promote the welfare of humanity and the elimination of pain and suffering through their own selfless service. Nominees should represent a personal activism that has led to longterm service to the community.

**Community Building Award:** Nominees must be individuals or organizations who have made significant contributions toward building a sense of unity among Ohio citizens. Nominees must have demonstrated the ability to build safer communities through various area revitalization activities and programs. Nominators must demonstrate how the nominee has used Dr. King's vision of nonviolent social change to successfully bring people from diverse backgrounds together to build a better community.



Economic Opportunity Award: Nominees, which may be individuals, municipalities, businesses or other organizations, must seek to improve the quality of life for citizens in economically challenged areas through economic incentive programs. Nominees must demonstrate accomplishments in one or more of the following areas: workforce training development programs; upgrading skills of existing workforce; infrastructure improvements; creation of community partnerships; housing assistance programs; energy efficiency programs; environmental programs; encouragement of new business startups; ability to take advantage of State and federal aid to provide economic opportunity.

Educational Excellence Award: Nominees in this category must have demonstrated a personal commitment to scholarship and/or attainment of educational goals despite significant barriers or obstacles (e.g., learning disability, poverty, etc.). Nominees also must have successfully achieved progress in eradicating systemic barriers that impede the attainment of academic excellence. The activities/programs of the nominees could include mentoring, tutoring, innovative pre-school programs, highly effective pre-college programs or the provision of scholarships, etc. Nominees must show a commitment to Dr. King's dream of social justice for all Americans through the provision/use of equal access to the means/resources of learning and the full utilization of educational opportunities.

Health Equity and Awareness Award: Nominees must have offered exemplary community outreach and educational programs for an under-served population in the state. These services should increase the accessibility (e.g., awareness, cost, transportation) of health care for the under-served while providing a high quality of customer service. Critical issues in achieving health equity and awareness can include provisions for drug treatment, HIV testing, screenings, prescription programs for the uninsured/underinsured, prenatal care and pediatric care. Organizations that provide health care and entities that facilitate health care delivery services are eligible to participate in this category. Nominations must document the support of services that progress toward the realization of Dr. King's vision of an America that provides the real promise and fulfillment of hope for the poor.

Social Justice Award: Nominees must have made significant contributions to achieving justice for individuals or communities. Nominees have made contributions through the legal, legislative and governmental systems on behalf of society's more vulnerable populations (e.g., sentencing disparity, red lining, census under counting, voter registration, environmental justice, etc.). The nominees must have participated in activi-

rary employment for up to 16 weeks. Apprentices become full-time highway technicians when they complete the program. In addition, the agency's Second Chance Apprentice Program links individuals soon to be released from the Ohio Reformatory for Women with opportunities for a pathway to full-time employment with the agency.

- The Ohio Department of Insurance (251 to 1,000 employees) Seeking to add more individuals who identify as Asian, Hispanic/Latino, and Native American, ODI forged partnerships with several specialized organizations. Job postings are shared with multiple organizations such as the Asian American Center, Asian/Pacific Islander Advisory Council, Philippine American Society of Central Ohio, and the Commission on Hispanic/Latino Affairs. The agency's equal opportunity officer also frequents specialized job fairs and festivals to connect with these groups.
- The Ohio Office of Budget and Management (Fewer than 251 employees) – OBM took several steps to construct its recruitment pipeline. First, it formed relationships with high schools, colleges and universities to help students develop skills necessary to join the agency. OBM also shares position openings with their fellow agency, Opportunities for Ohioans with Disabilities, to connect disabled Ohioans with meaningful work at the agency. The agency also is pursuing the development of a similar pipeline to recruit women in finance.

Youth: Capturing the Vision of Dr. Martin Luther King, Jr. Award: Nominees must be younger than 21 on Sept. 30, 2019. Nominees must exemplify leadership, nonviolence, commitment to excellence and interracial cooperation as well as demonstrate an adherence to one or more of Dr. King's Six Principles of Nonviolence: "Nonviolence is a way of life for courageous people; the Beloved Community is the framework for the future; attack forces of evil, not persons doing evil; accept suffering without retaliation for the sake of the cause to achieve the goal; avoid internal violence of the spirit as well as external physical violence; and, the universe is on the side of justice."
