The theme of this year's symposium is 'Inclusion through Innovation.' In addition, the keynote speaker will be Joe DeLoss, the owner of Hot Chicken Takeover. His restaurants, initially established in Columbus, provide supportive jobs to men and women who need a fair chance at work. No matter the circumstances — homelessness, previous incarceration, or other barrier to employment — Hot Chicken Takeover is focused on the future and is dedicated to offering team members meaningful benefits, such as financial stability, personal growth, and professional development.

Attendees will also hear from Governor DeWine, ODOT Director Jack Marchbanks, Major General John Harris from the Ohio National Guard, and more! Musical performances by the Sammy DeLeon Band and World House Choir will entertain participants during transitions between workshops. Presentation of 2020 scholarship and Ohio Transportation Excellence in Diversity and Inclusion award winners.

Get off our necks

I have been watching the Derek Chauvin trial. I watched the videos. Videos that hadn't been seen in public before. I cried. How can one justify placing a knee on someone's knee for over nine minutes? How can someone listen to a men beg for mercy and his life and not respond appropriately? Everyday people who witnessed the murder testified in court. They shed tears in public after their inability to render aid to George Floyd. George

Floyd was a man. He deserved dignity and respect.

Some have described the viral video as a metaphor for the Black experience in America. Civil rights activist Reverend Al Sharpton eulogized George Floyd.

"George Floyd's story has been the story of black folks because ever since 401 years ago, the reason we could never be who we wanted and dreamed to being is you kept your knee on our neck. We were smarter then the underfunded schools you put us in, but you had your knee on our neck. We could run corporations and not hustle in the street, but you had your knee on our neck. We had creative skills, we could do whatever anybody else could do, but we couldn't get your knee off our neck. What happened to Floyd happens every day in this country, in education, in health services, and in every area of American life, it's time for us to stand up in George's name and say get your knee off our necks.

That's the problem no matter who you are. We thought maybe we had ...maybe it was just us, but even blacks that broke through, you kept your knee on that neck. Michael Jordan won all of these championships, and you kept digging for mess because you got to put a knee on our neck. White housewives would run home to see a black woman on TV named Oprah Winfrey and you messed with her because you just can't take your knee off our neck. A man comes out of a single parent home, educates himself and rises up and becomes the President of the United States and you ask him for his birth certificate because you can't take your knee off our neck.

The reason why we are marching all over the world is we were like George, we couldn't breathe, not because there was something wrong with our lungs, but that you wouldn't take your

7 Financial Literacy Tips For Kids and Teens



- Start a habit of saving money. Whether someone gives
 your child five bucks or you just got your first paycheck,
 whatever money they are making (or receive), try to have
 them save at least 10% in an account (do not touch!).
- Start a budget. Help your child open up your own savings account and learn the basics of having a bank account. Help them start a budget and learn to manage it.
- 3. Shop around. Teach your kids this—it's tempting to see something we like and buy it on the spot, and that's called instant gratification. But if you go online or wait a couple of months for a sale, that same item may cost less which saves you money.
- 4. Avoid credit cards at all costs. You should start talking to your child about credit in their teens. If they plan on buying an awesome car, buying a house one day, or being taken seriously in any business venture, their credit score will play a huge role in how much financial companies will trust your spending habits. Have these discussions and help them understand the importance of having good credit.
- 5. Focus on earning. Kids need to know that saving is very important, but if they're not earning money, they won't have any to save. Have them start thinking like an entrepreneur at an early age. Help them open a lemonade stand, car washing business or pet walking service. The key is to offer a service that people are willing to pay for.
- Expect more. People usually make the amount of money they feel they are worth, and most people sell themselves short. Teach children to have a high self-image, and they



Networking Flowchart

Once you have established a plan for your networking, do you have a method for building relations? Are you intentional about creating a viable network for personal, academic and professional success? Are there ways that you can be innovative in connecting and adding value? Many savvy networkers join a club, attend events, etc. but may not take a step further to foster their contacts. Similarly to marketing, sales and engagement for companies, savvy networkers should create a funnel for their ac-

tivities. This is an excellent way to navigate through their networks, monitor their progress and make necessary adjustments.

Listed below are helpful tactics for formulating a path for effective processes.

Necessary Check Ins. Once you have established a bond and followed up, make it a point to stay constant. Be responsive with communication and learn more about your counterparts. The more you know about your contacts, the more effective you can be in connecting and vice versa. Checking in from time to time keeps you (and your connections) apprised on events and happenings. Also, it provides a platform to show support, sponsor initiatives and remain top of mind.

Necessary Engagement. Along with checking in, it is very important to engage the individuals in your networks. Offer value, exchange resources and be available when applicable. There are many benefits to having a lively network such as: access to opportunities and chances to develop. As well as, reasons to increase your digital footprint and offline brand. Engagement can look like many things. Liking, re-posting, tagging, etc. are great examples which can boost your trending capacities. Also, using these methods can expand your digital exposure to further link up with others.

Necessary Feedback. If your networks grow silent, be purposeful in your outreach. Choose to schedule meetings / meet-ups, request times to intentionally connect for relationship building. Do your due diligence and mention your intentions and means for holding the session. While communicating with your counterparts, ask for their feedback. Ask for ways that you can support or enhance the relationship. Definitely garner feedback to improve your strategies and enlarge your influence. Make sure to follow up with any suggestions made.


